### **REFERENCE PERIOD:**

June 2020

#### AIM:

To study the *Finance* students' the opinion on study subjects / modules their quality, and teaching.

#### **QUESTIONNAIRE:**

Students studying at *Finance* study programme evaluated the quality of study subjects / modules according to 14 criteria. Rating scale: *Strongly Agree; Agree; Neither Agree norDisagree; Disagree; Strongly Disagree.* Forty-five completed questionnaires were received.
