## **REFERENCE PERIOD:**

February 2021

AIM:

To study the *Finance* students' the opinion on study subjects / modules their quality, and teaching.

## **QUESTIONNAIRE:**

Students studying at *Finance* study programme evaluated the quality of study subjects / modules according to 14 criteria. Rating scale: *Strongly Agree; Agree; Neither Agree nor Disagree; Disagree; Strongly Disagree.* Seventy-four completed questionnaires were
